- □ While my appeal is being processed, I understand:
 - 1) CLASSES I need to attend all my classes and complete assignments.
 - 2) BOOKS I need to be prepared to purchase books and supplies on my own. I understand that I could use the Bookstore Charge Form to purchase my books and that I am responsible for all charges incurred at the bookstore.
 - 3) ICC CHARGES I am responsible for paying all charges (tuition, housing, fees, books, etc.) on my account. The denial of an appeal is not an acceptable reason for requesting a tuition refund.
 - 4) PROCESSING TIME (1-2 Weeks) Your appeal will be reviewed by the SAP Appeal Committee.
- □ If my appeal is <u>approved</u>, I understand:
 - 1) PROGRAM OF STUDY I can only enroll in courses required for my program of study.
 - 2) GRADES I must successfully complete all the classes in which I enroll.
 - 3) PROBATION STATUS I will be on financial aid Probation status for the appeal semester and must meet the conditions/terms set by the Appeal Committee
 - SATISFACTORY PROGRESS IN FUTURE TERMS If I do not make satisfactory progress or meet the conditions outlined in my appeal approval during the next semester, my financial assistance may be permanently suspended/terminated at ICC.
 - 5) TERMINATION Failing to meet the conditions of the probation status will result in being placed on termination status.
- □ If my appeal is <u>denied</u>, I understand:
 - 1) The committee decisions are FINAL
 - 2) I will need to pay my own expenses until I am back in good standing.
 - 3) I can regain eligibility for financial aid by completing enough credit hours to bring my cumulative completion rate to at least 67% and cumulative GPA to at least 2.0 at my own expense.
